Frequently Asked Questions

1. Who is the target audience for the eAnnouncementDirect service?

Your eAnnouncement will be sent to our database of more than 2,100 background screening firms.

In addition, we will post your eAnnouncement to relevant Background Screening Groups on LinkedIn extending its reach to more than 30,000 LinkedIn contacts.

Your eAnnouncement will also appear as a Featured Announcement in the edition of [The Background Buzz](#) that is published following the release of your announcement.

2. What do you consider to be an announcement?

Announcement Content: Common news angles include:

- information about an event you will be participating in,
- a speaking engagement,
- an organizational milestone like an anniversary,
- an award,
- a business expansion, merger or acquisition,
- opening a new office,
- a new hire
- issuance of a tip sheet, expert opinion on a topic currently in the news, ebook, white paper, etc.
- launch of a new product or service (must not be overly commercialized)

3. When will my eAnnouncement be distributed?

eAnnouncements are distributed, on-demand, so you are able to identify the time and date you would like your announcement distributed.

Please note that we will not send out an eAnnouncement on the same day that *The Background Buzz* is published. In general, this is the last day of each month.

4. How many words are allowed in the eAnnouncement?

You determine the length of your announcement, however, we recommend you keep it under 400 words so that when the reader opens the page they will view your entire announcement and not have to scroll down.

5. Can I include images in my eAnnouncement?

Yes.

6. What is the fee to send out an eAnnouncement?

The fee for an individual eAnnouncement is \$250.00.

You can also purchase a package of eAnnouncements:

- The fee for Three eAnnouncements is \$675.00
- The fee for Six eAnnouncements is \$1,312.50
- The fee for Twelve eAnnouncements is \$2,550.00
